### Parent and Family Engagement Policy Lewisville High School Harmon 2024 - 2025 School Year

  - Monitoring student progress and grades,
  - Meeting student academic, social, and emotional needs,
  - Technology, cyber safety and security, and digital citizenship,
  - Other services available through the school and district including but not limited to Communities in Schools, Harmon Help, federal TRIO programs, and more.

# PART III. DESCRIPTION OF HOW THE SCHOOL WILL COMMUNICATE WITH PARENTS AND GUARDIANS ABOUT SCHOOL ACTIVITIES AND PROGRAMS

- 1. Lewisville High School Harmon will provide parents and guardians with the following information in a timely manner:
  - School curriculum, state, district, and campus assessments and surveys, and student expectations,
  - Student handbooks that reference school protocols, grading processes, dress code, student codes of conduct, and more,
  - Skyward forms, using Skyward to check grades, and opportunities to receive assistance with completing required school forms,
  - Confidential Student Reports (CSRs) that reflect state assessment results, and district and campus accountability reports.
  - Notification that their student has been assigned or been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 7171-, December 2, 2002). This notification may also come directly from the district.
- 2. Lewisville High School Harmon will make reasonable efforts to provide communication with parents in their home language. Parent Night General Sessions will be offered in both English and Spanish.
