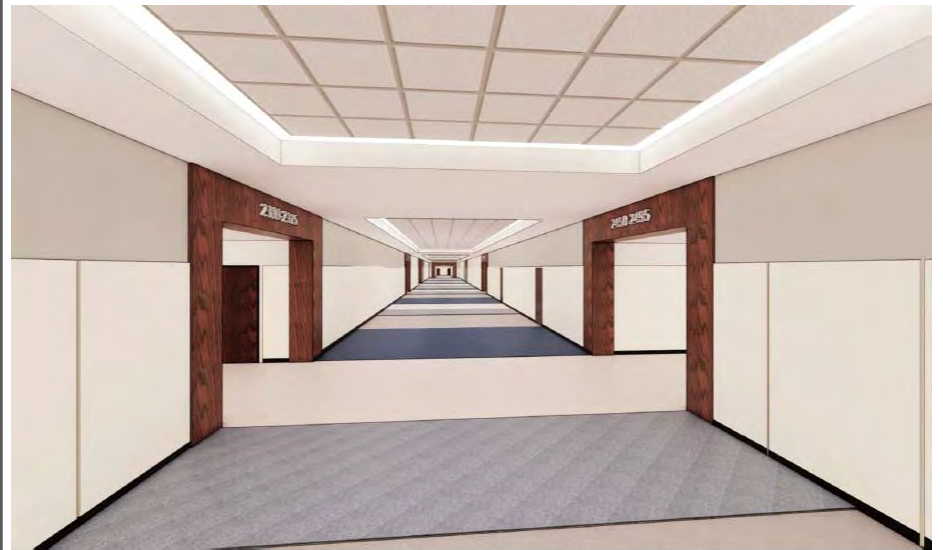
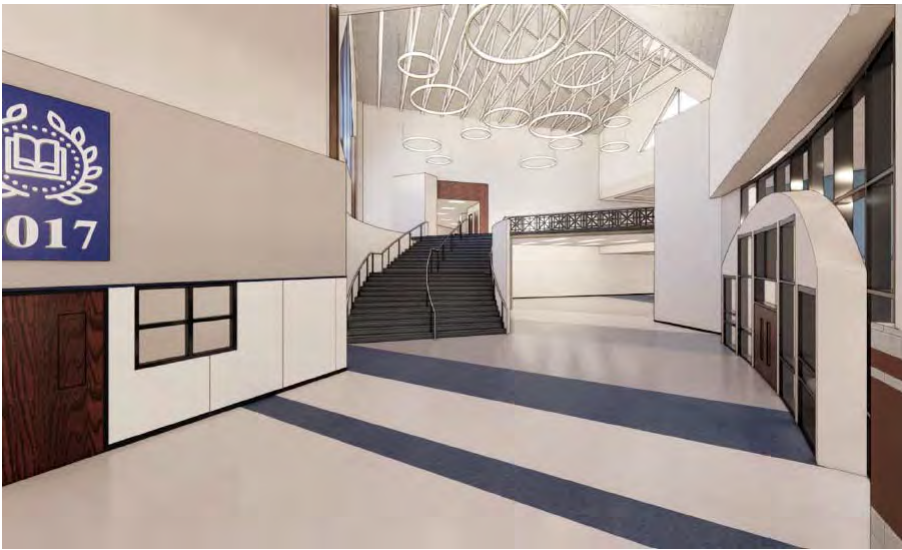

Covid-19 Update



- Covid-19 did have an impact on our construction projects
- There were fluctuating manpower issues
 - Some projects saw shortages in some trades
 - Some projects actually received more labor force early in the pandemic as a result of other construction shut downs
- Several of our projects had positive cases. Protocols were followed and individuals along with their immediate crews were quarantined. In almost every case, the sub-contractor was able to supplement with another crew and labor impacts were minimized.

- Most impacts were felt with material deliveries
 - Some plants and fabricators shutdown for periods of time
 - Some materials and suppliers were swapped to different ones on some projects to maintain schedules
 - The biggest delays affected doors, casework, room signage and plastic laminate wall panels. Other miscellaneous delays impacted individual projects.

- **All of our schools were able to open on time for in-person learning.**

Technology COVID-19 Update

- Implemented Cisco WebEx (collaboration, meeting, calling)
- Infrastructure
 - VPN Access
 - Expanded calling capacity to (2X) and call centers
 - Replaced filtering infrastructure
 - More users and split tunnel
 - WebEx calling readiness
- Provided exterior wireless at 26 campuses
- Wireless on Wheels at Bunker Hill Area
- Provided devices for students and staff



Fall 2020 Technology

- Develop and support processes to support COVID-19
 - Commitment Forms and new master schedules
 - Support approx. 50% of students being virtual
 - Data integrations/support for new systems
 - New Sign Sign On- ClassLink
 - COVID-19 Call Center
 - Deployed over 16K devices since Aug. 1st
 - Upgraded Bandwidth to 20 GB
 - Expanded Helpdesk
 - Continued to support WebEx

4,511 Unique Meeting Hosts
